<u>Independent investigation of the NHS in England: Lord Darzi's report on the state of the National Health Service in England</u>

In July 2024, the Secretary of State for Health and Social Care commissioned Lord Darzi to conduct an immediate and independent investigation of the NHS.

Lord Darzi's report provides an expert understanding of the current performance of the NHS across England and the challenges facing the healthcare system. Lord Darzi has considered the available data and intelligence to assess:

- patient access to healthcare
- the quality of healthcare being provided
- the overall performance of the health system

#### Lord Darzi's review and the need to invest in the health of our children

On 18 September, The Telegraph published an article by Annabel Denham titled "The mental health con is bankrupting Britain". This is our letter to the editor in response.

















RCN said nursing staff were shut out from pandemic response, as we gave evidence about the inadequate provision of PPE and infection prevention and control guidance.

The RCN has today (10 September) told the COVID-19 Inquiry that those representing the profession were effectively shut out from contributing to the pandemic response and key decision-making. Our repeated warnings about the spread of the virus and opportunities to protect nursing staff were either ignored or dismissed. We said there was a serious lack of critical thinking and engagement by the UK government and its agencies to consider the evidence around the airborne transmission of COVID-19.

# XEC: what you need to know about the new COVID variant

A new COVID variant is spreading rapidly and could soon become the dominant variant around the globe. The variant, called XEC, was first detected in Germany in August and appears to have a growth advantage over other circulating variants – but it is not a radically different variant.

Why has there been a sharp rise in health-related benefits claims in Britain but not in similar countries? Expert Q&A

Since 2019, real-terms spending on health-related benefits in Britain has increased by £12 billion and is set to continue growing, according to a new report from the Institute for Fiscal Studies. However, comparable countries, such as France, Australia and the US, have not experienced similar increases in spending.
